INTRODUCTION

Corruption is a major problem in Malaysia: It involves both the public and private sectors, making it a highly complex problem. It is likened to a contagious disease that will eventually destroy our economy and institutions. Corruption presents serious legal, reputational and financial risks to individuals and businesses. In the last five years, the Malaysian Anti-Corruption Commission (MACC) has arrested over 800 individuals in cases involving commercial organisation. The Malaysian Anti-Corruption Commission Act has been in existence since 2009, however cases of corruption involving the private sector is increasing by the year with no end in sight.

Best practices are designed to avoid bribery and corruption in organizations; however it has no effect if employees are not aware and trained about corruption issues. Anti-bribery training is a necessity, and this is especially true for organizations that are operating in a global market. Staff must be involved in a effective way of an anti-bribery and corruption training. Employees need to understand what anti-corruption means and why it is important and make personal commitments to ethical behaviors.

This Anti-bribery training will ensure that your employees are fully educated about the bribe and its various forms, the implications of taking a bribe, the current law and how a crime can be reported.

This training will discuss Malaysia's current corruption status, its effect on the economy and how they could contribute in the fight against corruption. 






MALAYSIANSKINI | Many years ago, child beggars used to crowd around the St Anne's Church in Bukit Mertajam during the patron saint's feast day. Some did not take kindly to them but for K Sudhagaran Stanley, it didn't just raise his concern but also his curiosity.

'I visited many of these families and had a personal relationship with them, trying to understand their needs, he said. Upon investigation, Stanley discovered that they were refugees, most of whom were Rohingya.

"I was concerned that these children were not going to school as they were not allowed into Malaysian public schools. They were very poor and living in deplorable conditions. They were easy targets of criminals gang recruits and human trafficking syndicates," he said.
